

Notice regarding Non-Consideration of Candidature for Further Selection Process
(Against Vacancy Notice Nos. 08/2026 to 20/2026)

With reference to NHRCL Vacancy Notice Nos. **08/2026 to 20/2026**, published on **10.06.2026**, with the last date for submission of online applications being **09.07.2026**, the candidates listed against the respective vacancy notices have **not been considered for the further stages of the selection process**, based on the information furnished by them in their online application forms.

The recruitment under the above vacancy notices is **on absorption basis** and is applicable **only to existing Regular/Contractual officers/managers working in Central Public Sector Undertakings/SPVs/Metro Railways/Ministry of Railways/Government Departments**, as prescribed in the respective vacancy notices.

Accordingly, candidates who have declared themselves as working in the private sector are **not eligible** and have not been considered for the further stages of the selection process. As it is not possible to scrutinize each and every individual application at this stage, some more candidates are likely to become ineligible for not meeting the above mentioned criteria. Such candidates are thus advised in their own interest not to participate in further recruitment process.

The candidature of all other candidates is **purely provisional** and subject to verification of documents and fulfilment of all eligibility conditions prescribed in the respective vacancy notices. Mere consideration for the further selection process shall not confer any right to appointment. If, at any stage of the recruitment process or thereafter, it is found that a candidate has furnished incorrect information or does not satisfy the prescribed eligibility criteria, his/her candidature shall be cancelled without any further notice.

Candidates who have not been considered for the further selection process and wish to submit a representation may do so by providing documentary proof establishing that, **as on the cut-off date (31.05.2026), they were Regular/Contractual Officers/Managers of Central Public Sector Undertakings/SPVs/Metro Railways/Ministry of Railways/Government Departments**.

Such representations, along with supporting documents, should be sent to **careers@nhsrcl.in** on or before **19.07.2026 (up to 16:00 hrs)**. Representations received after the stipulated date and time or without adequate supporting documents shall not be considered.
