


Report on Activities During Vigilance Awareness Week 2024 (28th October to 3rd November 2024)



Rules and Regulations


- » The slogan should be original

About NHSRCL Vigilance

NHSRCL Vigilance is the nodal organisation for handling all vigilance matters of the National High Speed Rail Corporation Limited, including its operations outside Delhi. The Chief Vigilance Officers (CVO) heads the unit.

Vigilance unit NHSRCL provides a link between the organization, the Vigilance unit of the Ministry of Railways and the Central Vigilance Commission.

The function of vigilance is to conduct preventive checks, suggest system improvements, investigate the complaints received from various sources, carry out detail CTE type investigation and investigate the observations raised by CTE during their intensive examination. The role of Vigilance is also to improve system & procedures of the organisation to eliminate/ reduce corruption and to promote transparency and ease of doing business. The objective is to develop a clean and efficient work culture to enhance the efficiency of the organisation.
